WHAT IS A FINAL PUBLISHED ARTICLE?

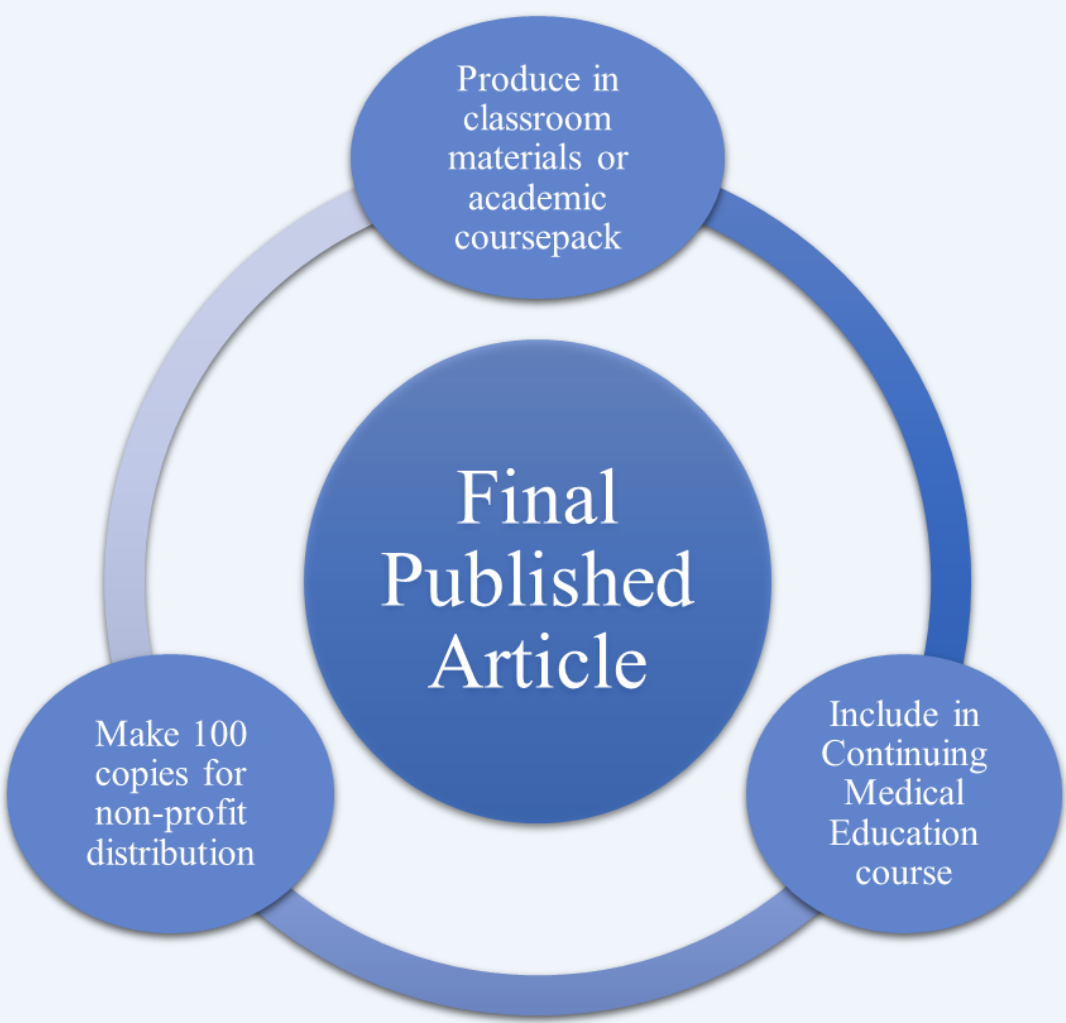

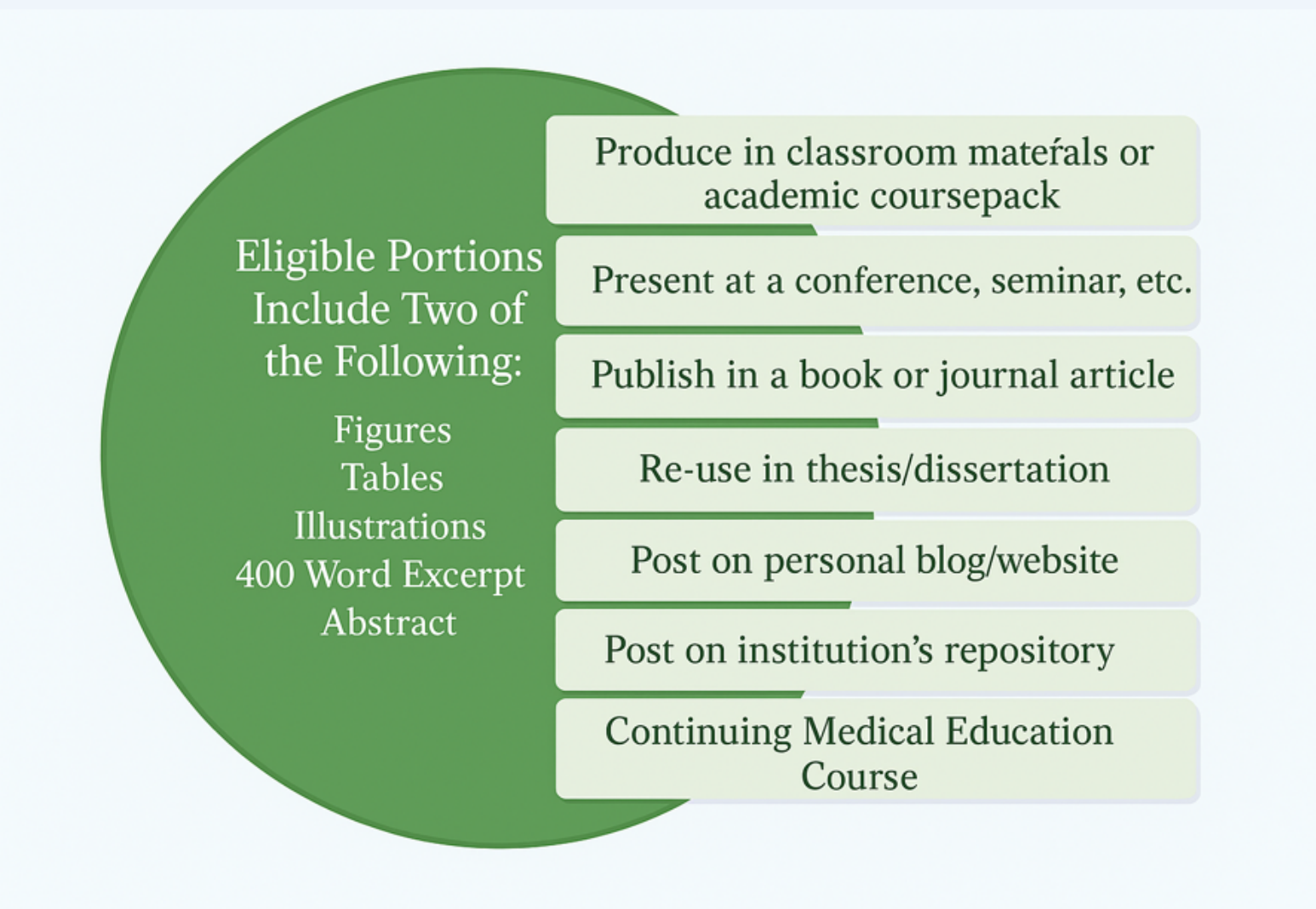
